Budget Proposal for "Evaluation of Neuroprotective and Anti Alzheimer's Effects of Some Indian Medicinal Plants".

Introduction:

The relevance of herbal shrubbery to counteractive incriminate in phytotherapy is solitary of the customary performs in the humanity. The various pharmacologically active secondary metabolites obtained from the different plant sources have significant neuro protective activity against the neuro degenerative disorders. Neurodegenerative disorder can be described as an irreversible gradual loss ofneuronal cell which is essential to perform the normal brain functions and the continuousloss of neuronal cell ultimately leads to brain death. Alzheimer's disease is defined as an irreversible neurological disorder which impairs the cognitive and intellectual function of human brain.

Scope of work

In this project, The fresh leaves of *Zagalatifolia*(ZL) and *Dalbergiadiphaca*(DD) were collected from local flora in Vellore district, Tamil Nadu India for the Neuro protective activity of Indian medicinal plants in Alzheimer's disease. The doses (200 mg/kg and 400 mg/kg) of ethanolic extracts of ZL and DD were used for the Neuroprotective activity of Indian medicinal plants in Alzheimer's disease. The tested doses at 200 mg/kg and 400 mg/kg of ethanolic extracts of DD showed significant neuroprotective behavioral study compared to the ethanolic extracts of ZL. These extracts bring back the declined level of brain neurotransmitters like dopamine, glutamate and antioxidant enzymes like catalase, glutathione peroxidase and glutathionereductase. *In vitro* neuroprotective activity for ethanolic leaves extracts of *Zagalatifolia*(ZL) and *Dalbergiadiphaca*(DD)*were*performedonSH-SY5Ycells. The ethanolic leaves extracts of ZL.

The phytocompounds isolated first time from the ethanolic leaves extracts of DD showedsignificant neuroprotective activity. The copper oxide nanoparticles synthesized from theethanolic leaves extracts of DD and ZL also showed very good neuroprotective activitythan the ethanolic leaves extracts of DD and ZL. This study suggests that ethanol leavesextracts of *Dalbergiadiphaca*have significant neuroprotective effect in the neurotoxicityinducedAlzheimer's diseasemodel.
